This first-ever Peace Institute is an intensive, interdisciplinary, three-day Institute for attorneys, mental health and financial professionals.

- Discuss the implications for confidentiality and preventive family professional services, and survey developments in conflict resolution and interdisciplinary teamwork;

The Peace Institute will be led by Forrest "Woody" S. Mosten, a nationally renowned authority in dispute resolution. David A. Hoffman, author, educator and practitioner, will deliver the keynote address at the Friday night Peacemakers' Dinner. Ample opportunities for networking with other peacemakers are planned.

Peacemaking and Management of Dispute Resolution, Part 1

CLE credits: 3 substantive and .5 ethics

This module introduces the central concepts and themes for the Institute. The focus will be on the roles for attorneys, mental health professionals and financial neutrals and ethical issues regarding peacemaking. It will also explore establishing a peacemaking signature (core values, attributes, type and style of services offered to the public and demographics of clients served) and designing your career as a peacemaker and manager of dispute resolution. Attendees will compare the impact of peacemaking from the neutral roles as mediator and evaluator, as well as consulting with and rendering service to individual clients. Attendees will learn the use and elements of apology and forgiveness and how to teach clients to offer apologies in family matters and handle refusal of the other party to accept an apology.
